2. Plant rental includes daily watering or change-out, as necessary, depending on the length of the rental.
3. All information requested on this form including the delivery date, delivery time, meeting room location and booth number (if applicable) must be provided before order can be processed.
4. Rates are subject to change without notice. Customers will be charged the prevailing rates on the date order is received by HCC.
5. Rates include complimentary delivery of palm(s) to your booth or meeting room.
